

ORDINANCE NO. 452

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF HIGHLAND,
CALIFORNIA, DESIGNATING THE LOCATION OF REGULAR MEETINGS
OF THE CITY COUNCIL OF THE CITY OF HIGHLAND AND
RESCINDING ORDINANCE NO. 236**

WHEREAS, in 1998 the City Council adopted Ordinance No. 236 establishing the days, time and location of the regular meetings of the City Council; and

WHEREAS, Government Code Section 36805 states the City Council shall hold regular meetings at least once a month at times fixed by ordinance or resolutions. It may adjourn any regular meeting or adjourned meeting to a date specified in the order of the adjournment. When so adjourned, the adjourned meeting is a regular meeting for all purposes.

THE CITY COUNCIL OF THE CITY OF HIGHLAND DOES HEREBY ORDAINS AS FOLLOWS:

Section 1. The City Council hereby rescinds Ordinance No. 236.

Section 2. Section 2.04.040 (Venue and time for meetings) of Chapter 2.04 (City Council) of Title 2 (Administration and Personnel) of the Highland Municipal Code is hereby amended to read as follows:

“The regular meetings of the City Council of the City of Highland shall be held at the Donahue Council Chambers, 27215 Base Line, Highland, California 92346, at 6 p.m. on Tuesdays based on a schedule set forth by Resolution No. 2022-001 of the City Council.”

Section 3. This Ordinance shall take effect thirty (30) days after adoption.


Section 4. Prior to the expiration of fifteen (15) days after its passage, this Ordinance shall be published and/or posted in at least three (3) public places designated by Resolution of the City Council of the City of Highland.

Section 5. The City Clerk shall certify to the adoption of this Ordinance.
